- 2. Examiners (Evaluators) for Evaluation of Workbooks and Conduct of Viva Voce:
 - (i) All Faculty Members of Commerce Discipline at SOMS, IGNOU and
 - (ii) Empaneled Examiners (evaluators)
- 3. Procedure for Empanelment of the Examiners (Evaluators):
 - (i) Eligibility of Examiner: Master' Degree in Commerce/ Management Discipline along with 5 years of teaching/ industry experience in the relevant area.
 - (ii) Procedure to Empanel the Examiners: The Regional Director shall identify the eligible examiners (evaluators) and send their CVs (including postal address, email and mobile number) to the Director, SOMS, IGNOU Maidan Garhi, New Delhi-110068. The Programme Coordinator will initiate the procedure for approval of the examiners. The lists of empaneled examiners shall be communicated to the RCs through Director, RSD.
- 4. Evaluation of Workbooks and Conduct of the Viva-Voce: The Regional Centre shall send the workbooks to the empaneled examiners (evaluators) for evaluation of workbooks and make necessary arrangements to conduct the Viva Voce for the local students through face to face and for the students residing out of station through online mode as per the option exercised by the students. One examiner can evaluate maximum of 20 workbooks and conduct their viva voce per day.
- Payment to the Examiner: The payment for evaluation of workbook and conduct of Viva-Voce shall be made as per the approved University norms (Notification No. IG/SED/EX-III/RR/2016 dated 23/03/2016 issued by the Registrar, SED) by the respective Regional Centre.
